2. Pastels, Printmaking, Drawing, Graphics
3. Sculpture
4. Mixed Media
5. Photography

Entry Deadline: Application must arrive no later than Friday, April 21, 2010.

Mail entry to: The Osceola Center for the Arts, 2411 E. Irlo Bronson Hwy, Kissimmee, FL 34744. Include a Self addressed stamped envelope for return of photos or slides.

Cost: \$15 non-refundable fee **for each work submitted**. Limit 3 works per artist total. Please enclose a check payable to The Osceola Center for the Arts.

Awards: \$300 for Best of Show, \$100 for First Place and 2nd and 3rd Place ribbons in each of five categories.

Reception: Tuesday, May 4 from 6pm to 8pm. Free and open to the public.

Entry Procedure

1. Each artist must submit a slide, photograph or *digital file for each work submitted. Please label submissions with following information: Name, Title, Medium, size and top (for slides). ***Digital files should be labeled with artist name plus submission number 1, 2, or 3, i.e. jdavidson-1.jpg or JulesDavidson-2.tiff etc.**
2. Supply an artist bio or statement with entry form.

Rules

1. All work must be original and **not** previously shown at the Center.
2. Art work must be framed and/or ready for display properly. (Subject to rejection upon receipt)
3. 2-D artwork is not to exceed 60 X 60 inches. Sculpture heights and sizes may vary based on space availability.
4. **Accepted works must be delivered to The Center on Wednesday, April 28th, from 9-1p and 3-5p.** Pick up date May 26th, 9-1p and 3-5p (*Artwork left for longer than 30 days from p/u date is subject to become property of OCFTA.*)
